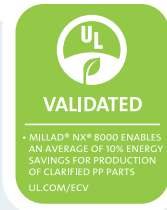

## PROCESSING TECHNIQUE

Cylinder Temperature	190 – 240 °C
Mold Temperature	50 – 80 °C
Injection Pressure	30 – 80 % of maximum pressure
Holding Pressure	Relative to injection pressure
Back Pressure	0 – 20 % of maximum pressure
Injection Speed	Low to medium of maximum pressure

However, the actual processing conditions depend on mold design, power of machine, equipment and other environments.
